

## New Machine and Parts Warranty

**SEAL-A-TRON Corporation** warrants to the original buyer that all the major parts and components of the products furnished hereunder will be free from defects in material and or workmanship under normal (**normal = 8 hours/day 5 days/week**) use for ONE FULL YEAR from the date of shipment from the seller's factory or warehouse. This warranty shall not apply to products which have been subject to misuse, neglect, accident, improper installation or abnormal conditions of temperature, dirt, water or corrosion, or to parts that customarily require periodic replacement such as seal wire, tape, silicone rubber, etc... **ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, ARE EXCLUDED AND DISCLAIMED, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR ANY USE OR PURPOSE (WHETHER OR NOT SUCH USE OR PURPOSE HAS BEEN DISCLOSED TO SELLER IN SPECIFICATIONS AND DRAWINGS PREVIOUSLY OR SUBSEQUENTLY PROVIDED BY SELLER, AND WHETHER OR NOT SELLER'S PRODUCTS ARE SPECIFICALLY DESIGNED OR MANUFACTURED BY SELLER FOR BUYER'S USE OR PURPOSE).**

The seller's sole obligation under this warranty and the buyer's sole exclusive remedy shall be (1) the repair or replacement, at the seller's option, of any defective product, part or accessory thereof, F.O.B. seller's factory; or (2) at the seller's option, the return to buyer of the original purchase price for the product in exchange for its return to seller; in each case, provided that the defect is proved to the seller's satisfaction within ONE YEAR from the date of original shipment. The seller will not be liable for any repairs made outside the seller's factory without its PRIOR WRITTEN authorization. Specific authorization to return any product, part or accessory must be obtained from seller, and transportation charges shall be **PREPAID** by the buyer.

**IN NO EVENT SHALL THE SELLER BE LIABLE FOR ANY SPECIAL, PUNITIVE, CONSEQUENTIAL OR INCIDENTAL DAMAGES TO ANY PROPERTY OR ANY PERSON IN CONNECTION WITH THE SALE, SHIPMENT, INSTALLATION OR USE OF THE PRODUCTS, AND THE BUYER AGREES TO INDEMNIFY AND HOLD THE SELLER HARMLESS AGAINST SUCH DAMAGES.**
